Now, therefore, in exercise of the powers conferred by sub-section (2) of Section 4 of the said Act, the Governor of Tamil Nadu hereby authorizes the Special Tahsildar (L.A.), Chennai Unit I, Chennai Metro Rail Limited, No. 2, Alwarpet Street, Alwarpet, Chennai-18, and his staff and workmen to exercise the powers conferred by the said sub-sections.
