DRAFT VARIATION TO THE LIST OF PARKS, PLAY - FIELDS AND OSR LAND FOR TIRUCHIRAPPALLI CORPORATION, SRIRANGAM DIVISION UNDER TAMIL NADU PARKS, PLAY-FIELDS AND OPEN SPACES (PRESERVATION AND REGULATION) ACT.

Whereas in G.O. (Ms.) No. 562, Education Department, dated 17-04-1967 a list of Parks, Play-fields and Open Spaces in the area within the jurisdiction of the then Tiruchirappalli Municipal Council was approved under sub-section (2) of Section 4 of the Tamil Nadu Parks, Play-fields and Open Spaces (Preservation and Regulation) Act, 1959 (Tamil Nadu Act 26 of 1959) and the same was published. In the said list among others, an extent of 22000 Sq. feet in Old T.S. Nos. 293 and 294/1 (New T.S.No. 44 part) was notified as Play-field.

- 2. And Whereas, the Director of Town and Country Planning from the Commissioner of Town and Country Planning letter Roc. No. 20158/2008/MP3, dated 12th November 2008 has stated that the Directorate approved the building plan for the construction of Library building in T.S.No.36, inside the campus of the St.Joseph College, Tiruchirappalli. The management of the St. Joseph College has represented that contrary to the site for which the plan for library building was approved to be constructed, the said library building has been constructed in T.S. No. 44 part, which was notified as Play-field site. The Petitioner has requested that an alternative site in the same campus in T.S.No. 40 with the same extent may be renotified as Play-field site instead of T.S. No. 44 part.
- 3. And Whereas, the Government, after careful examination of the proposal of the Director of Town and Country Planning regarding the representation of the management of the St.Joseph College, have decided to accept the same.
- 4. Now Therefore, the following draft of the variation to the approved list of Parks and Play-fields published in the Education Department notification No.75 of 1967 in Part II—Section 3 at pages 534 to 540 of the Fort St. George Gazette, dated the 14th June 1967, which it is proposed to make in exercise of the powers conferred by sub-section (1) of Section 5 of the Tamil Nadu Parks, Play-fields and Open Spaces (Preservation and Regulation) Act, 1959 (Tamil Nadu Act 26 of 1959) is hereby published as required under sub-section (2) of the said section.
