Narayanan, Chairman, Ayodhiyapattinam Panchayat Union Council, Salem District had been carried with a support of sixteen members out of the sanctioned strength of nineteen members of the said Panchayat Union Council in the meeting convened by the Revenue Divisional Officer, Salem, on 22nd January 2010, after following the procedures specified in Section 212 of the said Act and forwarded the same to Government;
