Now, therefore in exercise of the powers conferred by sub-section (2) of Section 4 of the said Act, the Governor of Tamil Nadu hereby authorizes the Special Tahsildar (Land Acquisition), Chennai Metro Rail Limited, Chennai Unit-II, No.2, Alwarpet Street, Alwarpet, Chennai – 18, and his staff

and workman to exercise the powers conferred by the said sub-sections.

Under Section 3(c) of the Act, the Governor of Tamil Nadu, hereby appoints the Special Tahsildar (Land Acquisition), Chennai Unit-II, Chennai Metro Rail Limited, No.2, Alwarpet Street, Alwarpet andChennai–18 to perform the functions of the Collector under the said Act.

Under sub-section 4 of Section 17 of the said Act, the Governor of Tamil Nadu hereby directs that in view of the urgency of the case, the provisions of Section 5A of the said Act, shall not apply in this case.
