ACQUISITION OF LANDS

Whereas, in exercise of the powers conferred by clasue (1) of the Article 258 of the Constitution of India, the President of India, has, in the Ministry of Food, Agriculture, Community Development and Co-operation (Department of Agriculture) Notification No.4(1)/65 General-II, dated 23rd April 1966, entrusted to the Government of Tamil Nadu with their consent, the functions of the Central Government under the Land Acquisition Act, 1894 (Central Act I of 1894), in relation to acquisition of lands for the purpose of the Union in this State;

And, whereas, the lands specified in the Schedule below are needed for a public purpose, to wit, for Villupuram – Katpadi Broad Gauge Railway Line for the formation of Pennathur Railway Station, notice to that effect is hereby given to all to whom it may concern, in accordance with the provisions of sub-section (1) of Section 4 of the Land Acquisition Act, 1894 (Central Act I of 1894);

And, whereas, it has become necessary to acquire to immediate possession of the lands specified in the Schedule below, the Governor of Tamil Nadu hereby directs that the lands be acquired under the provision of sub-section (2) of Section 17 of the said Act; Now, therefore, in exercise of the powers conferred by sub-section (2) of Section 4 of the said Act, the Governor of Tamil Nadu hereby authorizes the Tahsildar, Vellore, Vellore District, his staff and workmen to exercise the powers conferred by the said sub-section;

Under sub-section (4) of Section 17 of the said Act, the Governor of Tamil Nadu hereby directs that, in view of the urgency of the case, the provisions of Section 5-A of the said Act shall not apply to this case.
