AMENDMENTS TO TAMIL NADU LIQUOR (SUPPLY BY WHOLESALE) RULES, 1983.

### No. SRO A-9(b)/2011.

In exercise of the powers conferred by Section 54 read with Sections 17-C, 17-D, 17-E, 18-B, 18-BB, 18-C, 20 and 21 of the Tamil Nadu Prohibition Act, 1937 (Tamil Nadu Act X of 1937), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Liquor (Supply by Wholesale) Rules, 1983:—

#### **AMENDMENTS**

In the said Rules, in rule 13, for sub-rule (2), the following sub-rule shall be substituted, namely:—

"The licensee shall pay special fee in the case of Indian-made Foreign Spirits and foreign liquor imported at the rates specified in the following Table, namely:—
