And, whereas the lands specified in the schedule below or needed for a public purpose, to wit, for Establishment of 765/400 KV SS at Tiruvalam, notice to that effect is hereby given to all to whom it may concern in accordance with the provisions of sub-section (1) of Section 4 of the Land Acquisition Act,1894 (Central Act 1 of 1894).
