Whereas in exercise of the powers conferred by clause (1) of Article 258 of the constitution, the President has entrusted to the Government of Tamil Nadu in Letter No. 4(1)/65 General II Food, Agriculture Community Development and Co-operation (Agriculture), dated 23rd April 1966, with their consent the functions of the Central Government under the land acquisition Act, 1894 (Central Act 1 of 1894) in relation to acquisition of land for the purposes of the union in this state whereas it has already been decided that the compensation should be paid by the public revenues.
