Where in exercise of the powers conferred by clause (1) of the Articles 258 of the Constitution of India, the President of India has, in the Ministry of Food, Agriculture, Community Development and Co-operation (Department of Agriculture) Notification No. 4(1)/65, General-I & II, dated the 23rd April 1966, entrusted to the Government of Tamil Nadu with their consent the function of the Central Government under the Land Acquisition Act, 1894 (Central Act I of 1894) in relation to acquisition of land for the purpose for the Union in this State.

And, whereas, it has already been decided that the compensation shall be paid from the public revenue;

Now, therefore, in exercise of the powers conferred by Section 6 of the said Act, the Governor of Tamil Nadu hereby declares that the lands specified in the Schedule below and measuring 0.00.5 (Dry) Hectare and 0.0016.00 (Village Natham) Sq.Mtr. of 125. Parapatty Village, Salem Taluk, Salem District be the same a little more or less are needed for a public purpose, to wit for Salem-Broad Gauge Project.
