In exercise of the powers conferred by Section 24 of the Tamil Nadu Motor Vehicles Taxation Act, 1974 (Tamil Nadu Act 13 of 1974), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Motor Vehicles Taxation Rules, 1974:—

#### AMENDMENTS

In the said Rules, in rule 3-A,
