ELECTION SYMBOLS (RESERVATION AND ALLOTMENT) ORDER, 1968.

#### No. SRO G-41/2012.

The following Notification of the Election Commission of India, Nirvachan Sadan, Ashoka Road, New Delhi-110 001, dated 5th November, 2012 [14 Kartika, 1934 (Saka)] is republished:—

**No. 56/2011(vi)/PPS-II.**—In pursuance of sub-paragraph (2) of paragraph 17 of the Election Symbols (Reservation and Allotment) Order, 1968, the Election Commission of India hereby makes the following amendments to its Notification No. 56/2011/PPS-II, dated 28-12-2011, as amended from time to time, namely:—
