APPOINTMENT OF MANAGING DIRECTORS IN CERTAIN PRIMARY LEVEL WEAVERS' CO-OPERATIVE SOCIETIES UNDER THE TAMIL NADU CO-OPERATIVE SOCIETIES ACT.
