#### **COMMERCIAL TAXES AND REGISTRATION DEPARTMENT**

AMENDMENT TO THE TAMIL NADU SOCIETIES REGISTRATION RULES, 1978. [G.O. Ms. No. 76, Commercial Taxes and Registration (M1), 25th June 2013, ஆனி 11, விஜய, திருவள்ளுவர் ஆண்டு–2044.]

#### No. SRO A-17(a)/2013.

In exercise of the powers conferred by section 56 of the Tamil Nadu Societies Registration Act,1975 (Tamil Nadu Act 27 of 1975), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Societies Registration Rules, 1978.

2. The amendment hereby made shall come into force on the 1st day of July 2013.

#### AMENDMENT

In the said Rules, after rule 48, the following rule shall be inserted, namely:-

- "48-A. Condonation of delay with fine-(1) For the purpose of sub-section (2) of section 49, the authority competent to condone the delay in complying with the time limit referred to in that sub-section shall be, the Registrar of the District concerned up to a period of three years, the Inspector General of Registration for a period of from three years to five years and the Government for a period above five years.
- (2) The amount of fine to be collected for such condonation of delay after the time limit referred to in sub-section (2) of section 49 shall be as specified in the table below -

#### THE TABLE

Provisions of the Act (1)

- (i) Sub-section (1) or sub-section (2) of Section 4
- (ii) Sub-section (1) of section 13, sub-section (2) of Setion 15 and Section 27
- (iii) Sub-section (3) of Section 16

Amount of Fine (2)

Rupees One hundred for the delay of every three months or part thereof.

Rupees Two hundred for delay of every three months or part thereof.

Rupees Five hundred per year or part thereof, up to five years.

Rupees One thousand per year or part thereof, after five years and up to ten years, in addition to the fine payable for five years.

Rupees one thousand five hundred per year or part thereof, after ten years, and upto fifteen years, in addition to the fine payable for ten years.

Rupees Two thousand per year or part thereof, after fifteenth year, in addition to the fine payable for fifteen years".
