##### ACQUISITION OF LANDS

Whereas it appears to the Government of Tamil Nadu that the lands specified in the Schedule below and situated in Fort-Tondiarpet Taluk, Chennai District are Needed for the formation of Rail Over Bridge at Kathivakkam High Road and Cochrane Basin Road Railway Level Crossing Scheme, Notice to have effect is hereby given to all to whom it may concern in accordance with the provisions of sub-section (1) of Section 4 of the Land Acquisition Act, 1894 (Central Act 1 / 1894 and whereas, it has become necessary to acquire the immediate possession of the land specified in the schedule below, the Governor of Tamil Nadu hereby directs that the lands be acquired under the provision of Section (2) of the Section 17 of the said Act.

Now, therefore in exercise of the powers conferred by sub-section (2) of Section 4 of the said Act, the Governor of Tamil Nadu hereby Authorizes Tahsildar, Fort-Tondiarpet Taluk and his staff, workmen to exercise the powers conferred by the said sub-sections.

Under sub-section (4) of Section 17 of the said Act, the Governor of Tamil Nadu hereby directs that in view of the urgency of the case, the provisions of Section 5-A of the said Act, shall not apply in this case.
