MAKING A PROVISION UNDER SECTION 53(1) OF ANNAMALAI UNIVERSITY

#### No. II(2)/HE/850(b-3)/2013.

Whereas the Academic Council of the Annamalai University which is an Authority of the University, shall consist of the Ex-officio Members and the Other-Members as specified in sub-section (1) of Section 22 of the Annamalai University Act, 2013 (Tamil Nadu Act 20 of 2013).

And Whereas item (e) under the heading "Class I – Ex-officio Members" in sub-section (1) of Section 22 of the said Tamil Nadu Act 20 of 2013 provides that the 'Deans of Faculties' shall be the Ex-officio Members of the Academic Council:

And Whereas item (b) under the heading "Class II – Other Members" in sub-section (1) of Section 22 of the said Tamil Nadu Act 20 of 2013 provides that three members from among the Deans of Faculties shall be nominated to the Academic Council by the Chancellor on the recommendation of the Vice-Chancellor;

And Whereas it is considered that the provision in item (b) under the heading "Class II — Other Members" in sub-section (1) of Section 22 of the said Tamil Nadu Act 20 of 2013, is redundant and there is no need to nominate three members from among the Deans of Faculties to the Academic Council under item (b), under the heading "Class II — Other Members" in sub-section (1) of Section 22 of the said Tamil Nadu Act 20 of 2013, since all the Deans of Faculties will be the Ex-officio Members of the Academic Council, by virtue of item (e) under the heading "Class I — Other Members" in sub-section (1) of Section 22 of the said Tamil Nadu Act 20 of 2013.

And Whereas sub-section (1) of Section 53 of the said Tamil Nadu Act 20 of 2013 empowers the Government to make, by notification, such provision as may appear to them to be necessary or expedient for removing any difficulty that may arise as to the first constitution or re-constitution of any authority of the University.

Now, Therefore, in exercise the powers conferred by sub-section (1) of Section 53 of the said Tamil Nadu Act 20 of 2013, the Governor of Tamil Nadu hereby makes the following provision, namely:—

"No nomination to the Academic Council of the Annamalai University from among the Deans of Faculties, under item (b) under the heading "Class II – Other Members" in sub-section (1) of Section 22 of the Annamalai University Act, 2013 (Tamil Nadu Act 20 of 2013), is necessary, since all the Deans of Faculties of the University will be the Ex-officio members of the Academic Council by virtue of item (e) under the heading "Class I – Ex-officio Members" in sub-section (1) of Section 22 of the said Tamil Nadu Act 20 of 2013".
