Whereas, in exercise of the powers conferred by Clause (1) of Article 258 of the Constitution the President has entrusted to the Government of Tamil Nadu in letter No.4(1)65 Central II Food and agriculture community Development and Co-operation (Agriculture), dated 23rd April 1966 with their consent to the functions of the central Government under Land Acquisition Act, 1894 (Central Act 1 of 1894) in relations to acquisitions of land for the purpose of the union in State.

And, whereas the lands specified in schedule below and situated in Sannanallur, Nannilam Taluk, Tiruvarur District are

needed for a Public purpose, to wit for the formation of Broad Gauge Railway line between Tiruvarur and Mayiladuthurai notice to that effect to hereby given to all to whom it may concern in accordance with the provisions of sub-sections 1 of Section 4 of the land acquisition Act, 1894. (Central Act of 1 of 1894)

Now, therefore, in exercise of the powers conferred by aforesaid section the Governor of Tamil Nadu hereby Specially Authorizes the Revenue Divisional Officer, Tiruvarur his staff and workmen to exercise the power conferred by the Section 4 (2) of the Act under Section 3(c) of the same Act. the Governor of Tamil Nadu hereby appoints Revenue Divisional Officer, Tiruvarur to perform the functions of the collector under sub-section 4 of the Section 17 of the said Act. the Governor of Tamilnadu hereby directs that in view of the urgency of the case the provisions of the 5A of the Act shall not apply to this case.

## No. II(2)/TRA/884(f-3)/2013.

Whereas, in exercise of the powers conferred by Clause (1) of Article 258 of the Constitution of India, the President of India, has in the Ministry of Food, Agriculture, Community Development and Co-operation (Department of Agriculture) Notification No.4(1)/65, General-II, dated 23rd April 1966, entrusted to the Government of Tamil Nadu with their consent, the functions of the Central Government under the Land Acquisition Act, 1894 (Central Act 1 of 1894), in relation to acquisition of lands for the purpose of the union in this State.

And whereas, the lands specified in the schedule below are needed for a public purpose, to wit, for the formation of Doubling Broad Gauge Railway line between Villupuram and Dindigul. Notice to that effect is hereby given to all to whom it may concern, in accordance with the provisions of sub-section (1) of Section 4 of the Land Acquisition Act, 1894 (Central Act 1 of 1894).

And, whereas it has become necessary to acquire the immediate possession of the Lands specified in the Schedule below, the Governor of Tamil Nadu hereby directs that the Lands to be acquired under the provisions of sub-section (2) of Section 17 of the said Act.
