Whereas, in exercise of the powers conferred by clause (1) of the Article 258 of the Constitution of India, the President of India, has, in the Ministry of Food, Agriculture, Community Development and Co-operation (Department of Agriculture) Notification No. 4(1)/65, General-II, dated 23rd April 1966, entrusted to the Government of Tamil Nadu with their consent, the functions of the Central Government under the Land Acquisition Act, 1894 (Central Act 1 of 1894), in relation to Acquisition of lands for the purpose of the union in this State.

And, whereas, the lands specified in the schedule below are needed for a public purpose, to wit, for the formation of 4th Broad Gauge Railway line between Tiruvallur and Arakkonam. Notice to that effect is hereby given to all to whom it may concern, in accordance with the provisions of sub-section (1) of Section 4 of the Land Acquisition Act, 1894 (Central Act 1 of 1894).

And, whereas it has become necessary to acquire the immediate possession of the Lands specified in the Schedule below, the Governor of Tamil Nadu hereby directs that the Lands to be acquired under the provisions of subsection (2) of Section 17 of the said Act.
