ACQUISITION OF LANDS

Whereas, in exercise of the powers conferred by Clause (1) of Article 258 of the Constitution of India, the President of India, has in the Ministry of Food, Agriculture, Community Development and Co-operation (Department of Agriculture) notification No.4(1)/65 General-II, dated 23rd April 1966, entrusted to the Government of Tamil Nadu with their consent the functions of the Central Government under the Land Acquisition Act, 1894 (Central Act 1 of 1894) in relation to the

acquisition of lands for the purpose of the Union in this State;

And, whereas, it has already been decided that the compensation should be paid from the public revenues;

Now, therefore, in exercise of the powers conferred by Section 6 of the said Act, the Governor of Tamil Nadu hereby declares the lands specified in the schedule below and Measuring 6.06.7 Hectares / 60670 Sq.mts. of lands to be the same, a little more or less, is needed for a public purpose, to wit, for formation of Doubling Broad Gauge Railway Line between Villupuram and Dindigul.

A plan of the lands are kept in the Office of the Revenue Divisional Officer, Perambalur may be inspected at any time during office hours.
