Class-II—Other Members.

- One member from among the Deans of Faculties nominated by the Chancellor on the recommendation of the Vice-Chancellor.
- One member having special knowledge in the field of law, Higher Education or Medical Science nominated by the Chancellor on the recommendation of the Government.
- One member Nominated by the Chancellor from Scheduled Castes / Schedule Tribes, Most Backward, Backward or Minority Classes on the recommendation of the Government.
- One member representing Public or Private Sectors, Industries and Research Institutions having special knowledge and practical experience in Industry and Commerce, nominated by the Chancellor on the recommendation of the Government.
- One member elected by the Tamil Nadu Legislative Asembly from among its members.
