[National Highways-NH 205 - Stretch from Padi to Thirunindravur section (Km 59/6 - 81/6) - declared as State Highways Urban stretch (SU) - Orders -Issued.]

ORDER:-

No. 34, Highways and Minor Ports (HV1), 19th March 2013.

The Government of India, Ministry of Road Transport and Highways, had notified the Padi-Tirupathi Road as NH-205 on 6th January 1999, and entrusted this road to National Highways Authority of India on 27th September 2005. This road has been taken over by National Highways Authority of India (NHAI) under National Highways Development Programme (NHDP) Phase III. The National Highways Authority of India has now taken up the four laning of this Road and awarded the project to M/s. Transstroy Tirupathi Tiruvallur Chennai Tollway Private Limited, Chennai on 12th July 2010, excluding the 22km Stretch i.e. 59/6-81/6 from Padi to Tirunindravur. The total length of TN/AP Border-Renigunda-Tiruthani-Chennai Road (NH-205) is 81.60 Km (Km 0/0-81/6).

2. The District Collector, Tiruvallur in his letter first read above has stated that, Padi-Thirunindravur road is one among the four National Highways roads branching from the Chennai city, which leads to Tiruthani and Tirupathi. Most of the pilgrims are using only this road for travel to Tirupathi and Tiruthani from Chennai. Moreover, the stretch of Road from Km81/6-59/6 is passing through thickly populated urban area and Ambattur Industrial Estate area. He has therefore requested the Government to take up the works of widening and strengthening the stretch from Km 59/6 (Thirunindravur) to 81/6 (Padi).

3. The Chief Engineer (Construction and Maintenance) Highways Department in his letter second read above has requested the Government to declare the stretch km 59/6-81/6 of NH 205, Padi-Tirunindravur as State Highways Urban Stretch so that development works can be taken up in the plan schemes during the next financial year. 4. The issue was discussed in greater detail with the officials of Highways Department and after having elaborate discussion, the Government have decided to accept the proposals of the District Collector, Tiruvallur and Chief Engineer (Construction and Maintenance) Highways Department. Accordingly the Government hereby declare that the stretch from Padi-Tirunindravur of NH 205

(Km 59/6-81/6) as State Highways Urban stretch so as enable the Government to take up widening and strengthening of the stretch from Padi-Tirunindravur (Km 59/6-81/6).
