#### ACT No.1 OF 2014.

### An Act to amend the Tamil Nadu Infrastructure Development Act, 2012.

 $B_E$  it enacted by the Legislative Assembly of the State of Tamil Nadu in the Sixty-fifth Year of the Republic of India as follows:—

Short title and commencement.

- 1. (1) This Act may be called the Tamil Nadu Infrastructure Development (Amendment) Act, 2014.
  - (2) It shall come into force at once.

Amendment of section 3.

2. In section 3 of the Tamil Nadu Infrastructure Development Act, 2012 (hereinafter referred to as the principal Act), in sub-section (3), after clause (k), the following clause shall be inserted, namely:-

Tamil Nadu Act 22 of 2012.

"(kk) the Secretary to Government, Agriculture Department, ex-officio;".

Amendment of section 9.

- 3. In section 9 of the principal Act, in sub-section (2), after clause (j), the following clause shall be inserted, namely:—
  - "(jj) the Secretary to Government, Agriculture Department, ex-officio;".

ACT No. 2 OF 2014.

# An Act to amend the Chennai City Police (Extension to the Cities of Salem, Tiruchirappalli and Tirunelveli) Act, 1997.

BE it enacted by the Legislative Assembly of the State of Tamil Nadu in the Sixtyfifth Year of the Republic of India as follows:—

**1.** (1) This Act may be called the Chennai City Police (Extension to the Cities of Salem, Tiruchirappalli and Tirunelveli) Amendment Act, 2014.

Short title and commencement.

Amendment of

section 2.

- (2) It shall come into force on such date as the State Government may, by notification, appoint.
- **2.** In section 2 of the Chennai City Police (Extension to the Cities of Salem, Tiruchirappalli and Tirunelveli) Act, 1997, for clause (1), the following clause shall be substituted, namely:-

"(1) "City of Salem" means the area declared by the State Government, by notification, to be the City of Salem;".

ACT No. 3 OF 2014.

# An Act further to amend the Tamil Nadu Legislature (Prevention of Disqualification) Act, 1967.

BE it enacted by the Legislative Assembly of the State of Tamil Nadu in the Sixty-fifth Year of the Republic of India as follows:—

1. (1) This Act may be called the Tamil Nadu Legislature (Prevention of Disqualification) Amendment Act, 2014.

Short title and commencement.

Amendment of

Schedule.

(2) It shall come into force at once.

Tamil Nadu Act 3 of 1967.

2. In the Schedule to the Tamil Nadu Legislature (Prevention of Disqualification) Act, 1967, the following item shall be added at the end, namely:—

"12. The office of the chairman, chairperson, director or member of any statutory or non-statutory body, other than those specified above, on being elected, appointed or nominated to such office by the Legislative Assembly or the State Government, as the case may be, if the holder of such office is not entitled to any remuneration other than compensatory allowance.

Explanation.—For the purposes of this item,—

- (a) "compensatory allowance" means any sum of money payable to the holder of an office by way of daily allowance, conveyance allowance, house rent allowance or travelling allowance for the purpose of enabling him to recoup any expenditure incurred by him in performing the functions of that office;
- (b) "statutory body" means any corporation, committee, commission, authority, board, society, trust (by whatever name called) or other body of persons, whether incorporated or not, established by or under any law for the time being in force;
  - (c) "non-statutory body" means any body of persons other than a statutory body.".

ACT No. 4 OF 2014.

## An Act further to amend the Tamil Nadu Veterinary and Animal Sciences University Act, 1989.

BE it enacted by the Legislative Assembly of the State of Tamil Nadu in the Sixtyfifth Year of the Republic of India as follows:—

**1.** (1) This Act may be called the Tamil Nadu Veterinary and Animal Sciences University (Amendment) Act, 2014.

Short title and commencement.

Amendment of section 11.

(2) It shall come into force on such date as the State Government may, by notification, appoint.

Tamil Nadu Act 42 of 1989.

2. In section 11 of the Tamil Nadu Veterinary and Animal Sciences University Act, 1989,—

(1) to sub-section (1), the following proviso shall be added, namely:-

"Provided that if the Chancellor does not approve any of the persons in the panel so recommended by the Committee, he may take steps to constitute another Committee, in accordance with sub-section (2), to give a fresh panel of three different names and shall appoint one of the persons named in the fresh panel as the Vice-Chancellor.";

(2) in sub-section (2), for the expression "one shall be nominated by the Board", the expression "one shall be nominated by the Government" shall be substituted.

ACT No. 5 OF 2014.

### An Act further to amend the Tamil Nadu Fisheries University Act, 2012.

BE it enacted by the Legislative Assembly of the State of Tamil Nadu in the Sixtyfifth Year of the Republic of India as follows:—

1. (1) This Act may be called the Tamil Nadu Fisheries University (Amendment) Act, 2014.

Short title and commencement.

- (2) It shall come into force on such date as the State Government may, by notification, appoint.
- **2.** In section 4 of the Tamil Nadu Fisheries University Act, 2012 (hereinafter referred to as the principal Act), in clause (a), for the expression "to impart quality education", the expression "to impart quality professional education" shall be substituted.

Amendment of section 4.

3. In section 5 of the principal Act,-

Tamil Nadu Act

21 of 2012.

Amendment of section 5.

(1) in clause (o), the following expression shall be added at the end, namely:-

"and other statutory bodies related to fisheries of national and international level;";

- (2) clause (w) shall be omitted.
- 4. In section 19 of the principal Act,-

Amendment of section 19.

- (1) in sub-section (2),-
- (a) under the heading "CLASS I EX-OFFICIO MEMBERS", the items (e) and (f) shall be omitted;
  - (b) under the heading CLASS II OTHER MEMBERS,-
- (i) in item (a), for the expression "one fisheries scientist", the expression "one fisheries scientist or educationist" shall be substituted:
  - (ii) items (e), (i), (j) and (k) shall be omitted.
  - (2) for sub-section (3), the following sub-section shall be substituted, namely :-
- "(3) In case the Secretary to Government, in-charge of Fisheries or the Secretary to Government, in-charge of Finance or the Secretary to Government, in-charge of Law, is unable to attend the meetings of the Board, for any reason, he may depute any officer of his department not lower in rank than that of Deputy Secretary to Government to attend the meetings. The officer so deputed shall have the right to take part in the discussions of the meetings and shall have the right to vote."
- 5. In section 23 of the principal Act, in sub-section (1), under the heading "CLASS II OTHER MEMBERS", for the items (a), (b), (c), (d), (e) and (f), the following items shall be substituted. namely:
- "(a) Four members from amongst the Heads of Departments or Professors to be nominated by the Vice-Chancellor, on rotational basis;
- (b) One person having special knowledge or practical experience in different aspects of Fisheries to be nominated by the Vice-Chancellor; and
- (c) One Dean from the Indian Council of Agricultural Research recognised Fisheries College.".

An Act to provide for the appropriation of certain further moneys out of the Consolidated Fund of the State for the services and purposes of the financial year which commenced on the 1st day of April 2013.

BE it enacted by the Legislative Assembly of the State of Tamil Nadu in the Sixty-fifth Year of the Republic of India as follows:—

- 1. This Act may be called the Tamil Nadu Appropriation Act, 2014.
- 2. The State Government may appropriate out of the Consolidated Fund of the State for the services and purposes of the financial year which commenced on the 1st day of April 2013, a further sum not exceeding five thousand nine hundred and thirty seven crore sixty six lakh eleven thousand rupees, being moneys required to meet—
- (a) the supplementary grants made by the Tamil Nadu Legislative Assembly for that year, as set forth in column (3) of the Schedule; and
- (b) the supplementary expenditure charged on the Consolidated Fund of the State for that year, as set forth in column (4) of the Schedule.

Supplementary appropriation out of the Consolidated Fund of the State for the services and purposes of the financial year which commenced on the 1st day of April 2013.

ACT No. 7 OF 2014

An Act to provide for the withdrawal of certain sums from and out of the Consolidated Fund of the State for the services and purposes of a part of the financial year commencing on the 1st day of April 2014.

BE in enacted by the Legislative Assembly of the State of Tamil Nadu in the Sixty-fifth Year of the Republic of India as follows:-

1. This Act may be called the Tamil Nadu Appropriation (Vote on Account) Act, 2014.

2. The State Government may withdraw from and out of the Consolidated Fund of the State sums not exceeding eighty four thousand five hundred and eighty three crore thirty nine lakh and forty seven thousand rupees, being moneys required to meet—

- (a) the grants made in advance by the Tamil Nadu Legislative Assembly for a part of the financial year commencing on the 1st day of April 2014, as set forth in column (3) of the Schedule; and
- (b) the expenditure *charged* on the Consolidated Fund of the State for the said part of that year, as set forth in column (4) of the Schedule.

**3.** The sums authorised to be withdrawn from and out of the Consolidated Fund under section 2 shall be appropriated for the services and purposes expressed in the Schedule in relation to that year.
