In exercise of the powers conferred by section 8A of the Consumer Protection Act, 1986 (Central Act 68 of 1986), the Governor of Tamil Nadu hereby establishes, with effect on and from 07-12-2018 for a period of three years, the District Consumer Protection Councils for every District in the State of Tamil Nadu which shall consist of the following members:-
