The Government of Tamil Nadu, having been satisfied that the lands specified in the schedule below have to be acquired for Industrial purpose to Wit for the Establishment of New SIPCOT Industrial Park by SIPCOT at 29.Thadangam Village and surrounding areas, and it having already been decided that the entire amount of compensation to be awarded for the lands to be paid out of the lands controlled or managed by SIPCOT.
