The Government of Tamil Nadu having been satisfied that the lands specified in the schedule below are acquired under Tamil Nadu Road Sector Project II for Highways purpose for Widening of SH-222, Omalur – Mecheri Road at Chinnasathapadi and Periyasathapadi villages in Mettur Taluk, Salem District and it having already been decided that the entire amount of compensation to be awarded for the lands to be paid out of the funds controlled and managed by the Divisional Engineer(H), Salem (TNRFS II), Tamil Nadu after having considering the cause shown by the owner or other persons having interest on such lands as the case may be do hereby publish the following notice is issued under sub-section (1) of section 15 of the Tamil Nadu Highways Act, 2001 (TN Act 34 of 2002).

### NOTICE

Under sub-section (1) of section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002) the Governor of Tamil Nadu hereby notify that the Dry lands specified in the schedule below and measuring to an extent of 3821 sq.mts. of Dry lands are acquired in Chinnasathapadi and Periyasathapadi in Mettur Taluk, Salem District to the same, a little more or less needed for Tamil Nadu Road Sector Project II for State Highways purpose for Widening of SH-222, Omalur – Mecheri Road.
