**BILLS INTRODUCED IN THE LEGISLATIVE ASSEMBLY OF THE
STATE OF TAMIL NADU**

Under Rule 130 of the Tamil Nadu Legislative Assembly Rules, the following Bill which was introduced in the Legislative Assembly of the State of Tamil Nadu on 27th February, 2021 is published together with Statement of Objects and Reasons for general information:—

L.A. Bill No. 15 of 2021

A Bill to provide for the appropriation of certain further moneys out of the Consolidated Fund of the State for the services and purposes of the financial year which commenced on the 1st day of April 2020.

BE it enacted by the Legislative Assembly of the State of Tamil Nadu in the Seventy - Second Year of the Republic of India as follows:--

1. This Act may be called the Tamil Nadu Appropriation Act, 2021.

Short title.

2. The State Government may appropriate out of the Consolidated Fund of the State for the services and purposes of the financial year which commenced on the 1st day of April 2020, a further sum not exceeding Twenty One Thousand One Hundred and Seventy Two Crores Eighty Two Lakhs and Five thousand rupees, being moneys required to meet--

Supplementary appropriation out of the Consolidated Fund of the State for the services and purposes of the financial year which commenced on the 1st day of April 2020.

- (a) the supplementary grants made by the Tamil Nadu Legislative Assembly for that year, as set forth in column (3) of the Schedule; and
- (b) the supplementary expenditure *charged* on the Consolidated Fund of the State for that year, as set forth in column (4) of the Schedule.

L.A. Bill No. 16 of 2021

A Bill to provide for the withdrawal of certain sums from and out of the Consolidated Fund of the State for the services and purposes of a part of the financial year commencing on the 1st day of April 2021.

BE it enacted by the Legislative Assembly of the State of Tamil Nadu in the Seventy - Second Year of the Republic of India as follows:-

1. This Act may be called the Tamil Nadu Appropriation (Vote on Account) Act, 2021. Short title.
2. The State Government may withdraw from and out of the Consolidated Fund of the State sums not exceeding Two Lakh Twenty One Thousand Seven Hundred Sixty Six Crore Thirty Five Lakh and Forty Thousand rupees, being moneys required to meet--
 - (a) the grants made in advance by the Tamil Nadu Legislative Assembly for a part of the financial year commencing on the 1st day of April 2021, as set forth in column (3) of the Schedule; and
 - (b) the expenditure *charged* on the Consolidated Fund of the State for the said part of that year, as set forth in column (4) of the Schedule.Withdrawal of certain sums from and out of the Consolidated Fund of the State for a part of the financial year commencing on the 1st day of April 2021.
3. The sums authorised to be withdrawn from and out of the Consolidated Fund under section 2 shall be appropriated for the services and purposes expressed in the Schedule in relation to that year. Appropriation.

STATEMENT OF OBJECTS AND REASONS.

This Bill is introduced in pursuance of Article 206, of the Constitution, to provide for the withdrawal from, and out of, the Consolidated Fund of the State, of certain sums being required to meet.—

(a) the grants made in advance by the Tamil Nadu Legislative Assembly in respect of estimated expenditure of the State for a part of the financial year commencing on the 1st day of April 2021; and

(b) the expenditure charged on the said Fund for the said part of that year, and for the appropriation of the said sums.
