COVID-19 - INCREASE IN NUMBR OF COVID-19 CASES - COMPLETE LOCKDOWN ENFORCED THROUGHOUT THE STATE FROM 04.00 A.M. ON 10-05-2021 TO 04.00 A.M. ON 24-05-2021 - FURTHER RELAXATIONS - ORDERED -UNDER THE DISASTER MANAGEMENT ACT 2005.

Whereas considering the views expressed by the District Collectors during the meeting held on 7.5.2021 and in consultation with Medical Experts, taking into account the suggestions of the Ministry of Home Affairs and Ministry of Health and Family Welfare, Government of India to prohibit certain activities, complete lockdown is enforced throughout the State with effect from 4.00 AM of 10.5.2021 to 4.00 AM of 24.5.2021 in the Government order 31st read above.

- 2. In the press release dated 11.05.2021, certain additional relaxations for fruit shops, permitting all Industries to carryout maintenance works with bare minimum staff on one day only and for the functioning of Indigenous Medicine Shop were announced.
- 3. The Additional Chief Secretary/ Commissioner of Revenue Administration has accordingly sent draft amendment proposal to G.O.Ms.No.371, Revenue and Disaster Management (DM IV) Department dated 08.05.2021.
- 4. The Government after careful consideration here by ordered to amend the G.O.Ms.No.371, Revenue and Disaster Management (DM IV) Department, dated 08.05.2021 as detailed below: -

- A. The following content shall be added as Section (xix), (xx) and (xxi) under Caption II (Under Permitted Activities):
  - (xix) Platform vendors selling fruits shall be permitted upto 12.00 Noon.
  - (xx) During complete lock down, all Industries shall be permitted to carry out the maintenance works only on one day with bare minimum staff.
  - (xxi) Indigenous medicine (நாட்டு மருந்துக்கடைகள்) shops shall be permitted to function during complete lock down.
- B. The following content may be added as Section (iii) under Caption III (General): -
  - (iii) To resolve the issues in operating the Continuous Process Industries and Industries manufacturing essential commodities during the complete lockdown period, 24 Hrs Helpline shall be established in the office of the District Industries Centre (தொழில் வழிகாட்டி மையம்), Chennai with the following mobile numbers. 96771-07722, 99943-39191, 78239-28262, 96291-22906, 99629-93496, 99629-93497.
