The Government of Tamil Nadu having been satisfied that the lands specified in the Schedule below are acquired under Chennai Peripheral Ring Road Project for Highways purpose to wit, for formation of road connectivity from Ennore Port to Mahabalipuram (from KM. 55.461 to KM 57.668) at No. 95, Puttur (Block-II) Village, Tiruvallur Taluk, Tiruvallur District and it having already been decided that the entire amount of compensation to be awarded for the lands to be paid out of the funds controlled and managed by the Highways Department and after having considering the cause shown by the owner or other persons having interest on such lands, as the case may be, do hereby publish the following notice under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002) read with the Tamil Nadu Land Acquisition Laws (Revival of Operation, Amendment and Validation) Act, 2019.

Under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002), read with the Tamil Nadu Land Acquisition Laws (Revival of Operation, Amendment and Validation Act, 2019) the Governor of Tamil Nadu hereby notifies that the Wet, Dry and Manavari patta lands specified in the schedule below and measuring to an extent of 81,804 Sq.mtrs. of lands are acquired in No. 95, Puttur (Block-II) Village, Tiruvallur Taluk, Tiruvallur District to the same a little more or less needed for the purpose to wit for formation of road connectivity from Ennore Port to Mahabalipuram (from KM. 55.461 to KM 57.668) as part of Chennai Peripheral Ring Road Project, Highways Department.
