The following amendments to the Tamil Nadu Legislative Assembly Rules shall be deemed to have been approved by the Tamil Nadu Legislative Assembly on 22.8.2021 under sub-rule (3) of rule 259 of the said Rules and shall come into force on the date of publication in the *Tamil Nadu Government Gazette* Extraordinary, dated the 23rd August 2021.

2(1)(b1)	- NIL-	"Computer network" shall have the same meaning assigned to "computer network" in the Information Technology Act, 2000 (Central Act 21 of 2000)
2(1)(c1)	- NIL-	"Electronic record" shall have the same meaning assigned to "electronic record" in the Information Technology Act, 2000 (Central Act 21 of 2000)
2(1)(r1)	-NIL-	"Paper or any document including Bill, statement, notice laid on the Table" shall mean and include such paper or document in the form of electronic record through a computer network of the Legislative Assembly.

# Rule No. Existing Rule

- 30(1) A list of business for each day shall be prepared by the Secretary and circulated to all members
- 30(5) A paper shall be deemed to have been placed on the table of the Assembly or laid before the Assembly on the date on which a note to that effect is entered in the list of business for the day or is found in the proceedings of the Assembly. Copies of all such papers shall be made available to members.
- 181(1) The Annual Financial Statement or the statement of the estimated receipts and expenditure of the State in respect of every financial year (hereinafter referred to as "the Budget"), shall be presented to the Assembly on such day as the Governor may appoint.
- 181(3) -NIL-
- 182(2) Each Demand shall contain first a statement of the total grant proposed and then the details of each grant shown by sub-heads of appropriation under each grant.
- 189(1) The Governor may at any time during a financial year appoint a day for the presentation of a statement of supplementary or additional expenditure under Article 205.

#### Rule as amended

- A list of business for each day shall be prepared by the Secretary and circulated to all members in **physical** form or in the form of electronic record through a computer network of the Legislative Assembly.
- A paper shall be deemed to have been placed on the table of the Assembly or laid before the Assembly on the date on which a note to that effect is entered in the list of business for the day or is found in the proceedings of the Assembly. Copies of all such papers shall be made available to members in physical form or in the form of electronic record through a computer network of the Legislative Assembly.
- The Annual Financial Statement or the statement of the estimated receipts and expenditure of the State in respect of every Financial year (hereinafter referred to as "the Budget"), shall be presented to the Assembly in physical form or in the form of electronic record through a computer network of the Legislative Assembly on such day as the Governor may appoint.
- Nothing herein before contained shall be deemed to prevent the presentation of Budget to the Assembly in two or more parts.
- Each Demand shall contain first a statement of the total grant proposed and then the details of each grant shown by sub-heads of appropriation under each grant. The details of grant shall be made available in physical form or in the form of electronic record through a computer network of the Legislative Assembly.
- The Governor may at any time during a financial year appoint a day for the presentation of a statement of supplementary or additional expenditure under Article 205. Such statement shall be made available in physical form or in the form of electronic record through a computer network of the Legislative Assembly.
