REVENUE AND DISASTER MANAGEMENT DEPARTMENT

COVID-19 – INFECTION PREVENTION AND CONTROL - LOCK DOWN PROMULGATED TILL 31-1-2021 WITH CERTAIN RESTRICTIONS AND RELAXATIONS – INCREASE THE SEATING CAPACITY OF CINEMAS/THEATRES / MULTIPLEXES UNDER THE DISASTER MANAGEMENT ACT, 2005.

AMENDMENT TO NOTIFICATION

On considering the recommendations of the expert team of Doctors and Public Health Specialists and based on the directives of Government of India, Ministry of Home Affairs, State-wide lockdown was extended from time to time and lastly extended till 24:00 hrs of 31-1-2021 under the Disaster Management Act, 2005 in G.O.Ms.No.820, Revenue and Disaster Management (DM-IV) Department, dated 31-12-2020 with various relaxations and certain restrictions.

2. Based on the directives of Government of India, Ministry of Home Affairs, Cinemas/theatres/Multiplexes were permitted to open from 10-11-2020 with 50% of their seating capacity by following the Standard Operating Procedure in the Government Order fifth read above.

3. Based on the decrease in the COVID-19 cases day by day, the Theatre Owners Association have represented to Government to increase the seating capacity of Cinemas/theatres/Multiplexes.

4. Now, therefore the Government hereby **permit to increase the seating capacity of Cinemas/Theatres/Multiplexes from existing 50% to 100%** by following the Standard Operating Procedure issued already and issue following amendment to G.O.Ms.No.820, Revenue and Disaster Management (DM-IV) Department, dated:31-12-2020 as detailed below:

Under Caption II, the following section shall be added in addition to the existing permitted activities:

iv. The seating capacity of Cinemas/theatres/Multiplexes shall be permitted to increase from existing 50% to 100% by following the Standard Operating Procedure issued already. Further, in order to create awareness among the spectators, the precautionary measures for Covid-19 shall also be screened during the show time.
