AND WHEREAS, the Revenue Divisional Officer, Uthamapalayam, Theni district caused a copy of the statement of charges alongwith a copy of the notice of motion to be delivered, to the said Chairman Tmt.V.Jhansi and she submitted her reply to the charges;

AND WHEREAS, a motion expressing want of confidence in Tmt.V.Jhansi, Chairman, Uthamapalayam Panchayat Union Council, Theni district had been carried with a support of nine members out of the sanctioned strength of ten members of the said Panchayat Union Council in the meeting convened by the Revenue Divisional Officer, Uthamapalayam, Theni district on the 20th September 2021 after following the procedures specified in the said Section 212 and forwarded the same to Government;

NOW THEREFORE, in exercise of the powers conferred by sub-section (13) of Section 212 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994), the Governor of Tamil Nadu hereby removes Tmt.V.Jhansi, Chairman, Uthamapalayam Panchayat Union Council, Theni district from the office of the Chairman of the said Panchayat Union Council with immediate effect.
