NOTIFICATION BY THE ELECTION COMMISSION OF INDIA

ORDER OF THE ELECTION COMMISSION OF INDIA

DISQUALIFICATION OF CANDIDATE CONTESTED FROM 31. SIVAGANGA PARLIAMENTARY CONSTITUENCY IN THE GENERAL ELECTION TO HOUSE OF THE PEOPLE FOR FAILURE TO LODGE THE ACCOUNTS OF ELECTION EXPENSES UNDER SECTION 10-A OF THE REPRESENTATION OF THE PEOPLE ACT, 1951 BY THE ELECTION COMMISSION OF INDIA.

**No.76/TN-HP/2019.**— The following order of the Election Commission of India, Nirvachan Sadan, Ashoka Road, New Delhi-110 001, dated 6th October, 2021[14 Asvina, 1943 (Saka)] is re-published:

Whereas, the Election Commission of India is satisfied that the contesting candidate specified in column 4 of the Table below at the General Election to House of the People, 2019 from the State of Tamil Nadu specified in column 2 and held from the constituency specified in column 3 against his name has failed to lodge the account of his election expenses as shown in column 5 of the said Table as required by the Representation of the People Act, 1951 and the Rules made thereunder;

And whereas, the said candidate has either not furnished any reason or explanation for the said failure even after due notice by the Election Commission or after considering the representation made by them, if any, the Election Commission is satisfied that he has no good reason or justification for the said failure;

Now, therefore, in pursuance of Section 10A of the said Act, the Election Commission hereby declares the person specified in column 4 of the Table below to be disqualified for being chosen as and for being a member of either House of Parliament or the Legislative Assembly or Legislative Council of a State or of Union Territory for a period of three years from the date of this order: -
