Under sub-section (1) of Section 4 of the Tamil Nadu Acquisition of Land for Industrial Purposes Act, 1997 (Tamil Nadu Act 10 of 1999), the Governor of Tamil Nadu hereby withdraws from acquisition of the land/lands specified in the schedule below in respect of which notice under sub-section (1) of section 3 was published by the Industries Department in G.O.(Ms).No.96, dated 01.07.2011 at Page 1-6, Part-II, Section-2 of the *Tamil Nadu Government Gazette* No.200, dated 01.07.2011 and the Errata was published by the Industries (SIPCOT-LA) Department at Page No. 357 of Part II, Section 2 of the *Tamil Nadu Government Gazette* No.11, dated 19.03.2014 and the Government have also decided to withdraw the acquisition proceedings in G.O.(Ms).
