The Government of Tamil Nadu, having been satisfied that the lands specified in the schedule below have to be acquired for Industrial purpose to wit for the Establishment of new SIPCOT Industrial Park by SIPCOT at Athiyamankottai Village and surrounding areas, and it having already been decided that the entire amount of compensation to be awarded for the lands to be paid out of the lands controlled or managed by SIPCOT. The following notice is issued under sub-section (1) of Section 3 of the Tamil Nadu Acquisition of land for Industrial Purposes Act, 1997(Tamil Nadu Act 10 of 1999).

NOTICE

Under sub section (1) of Section 3 of the Tamil Nadu Acquisition of land for Industrial Purposes Act, 1997 (Tamil Nadu Act 10 of 1999), the Governor of Tamil Nadu hereby acquires the lands specified in the schedule below and measuring 7.42.5 Hectares (18.34 Acres) of dry lands to the same a little more or less needed for Industrial Purposes, to wit, for setting up of new Industrial Park by SIPCOT.
