the Tambaram City Municipal Corporation Ordinance, 2021 (Tamil Nadu Ordinance 5 of 2021) and the Kumbakonam City Municipal Corporation Ordinance, 2021 (Tamil Nadu Ordinance 4 of 2021), the Tambaram City Municipal Corporation Ordinance, 2021 (Tamil Nadu Ordinance 5 of 2021) and the Kumbakonam City Municipal Corporation Ordinance, 2021 (Tamil Nadu Ordinance 7 of 2021), the Governor of Tamil Nadu, after consultation with the Tamil Nadu State Election Commission, hereby makes the following amendments to the Tamil Nadu Town Panchayats, Municipalities and Corporations (Elections) Rules, 2006:-

AMENDMENTS

In the said Rules, --

(1) in rule 2, in sub-rule (1), in clause (i), —

for the expression “the Nagercoil City Municipal Corporation Act, 2019 (Tamil Nadu Act 11 of 2019) in respect of Nagercoil City Municipal Corporation; and

the Avadi City Municipal Corporation Act, 2019 (Tamil Nadu Act 24 of 2019) in respect of Avadi City Municipal Corporation, the following expression shall be substituted, namely:-

“the Nagercoil City Municipal Corporation Act, 2019 (Tamil Nadu Act 11 of 2019) in respect of Nagercoil City Municipal Corporation;

the Avadi City Municipal Corporation Act, 2019 (Tamil Nadu Act 24 of 2019) in respect of Avadi City Municipal Corporation;

the Cuddalore City Municipal Corporation Ordinance, 2021 (Tamil Nadu Ordinance 1 of 2021) in respect of Cuddalore City Municipal Corporation;

the Kancheepuram City Municipal Corporation Ordinance, 2021 (Tamil Nadu Ordinance 2 of 2021) in respect of Kancheepuram City Municipal Corporation;

the Sivakasi City Municipal Corporation Ordinance, 2021 (Tamil Nadu Ordinance 3 of 2021) in respect of Sivakasi City Municipal Corporation;

the Karur City Municipal Corporation Ordinance, 2021 (Tamil Nadu Ordinance 4 of 2021) in respect of Karur City Municipal Corporation;

the Tambaram City Municipal Corporation Ordinance, 2021 (Tamil Nadu Ordinance 5 of 2021) in respect of Tambaram City Municipal Corporation; and

the Kumbakonam City Municipal Corporation Ordinance, 2021 (Tamil Nadu Ordinance 7 of 2021) in respect of Kumbakonam City Municipal Corporation.”;

(2) in rule 25, in sub-rule (1), for “THE TABLE”, the following Table shall be substituted, namely:-
