The Governor of Tamil Nadu having been satisfied that the lands specified in the Schedule below have to be acquired for Highways purpose for construction of Western Ring-road to Coimbatore City at Kalikkanaickenpalayam Village, Perur Taluk, Coimbatore District and it has already been decided that the entire amount of compensation to be awarded for the lands is to be paid out of the funds controlled or managed by the Chief Engineer, Construction and Maintenance, Highways Department after considering the cause shown by the owner (or) other person having interest on such lands as the case

may be do hereby publish the following notice under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002).
