AND WHEREAS, it is necessary to appoint a Special Officer to exercise the powers and to discharge the functions of the Kumbakonam City Municipal Corporation under the Kumbakonam City Municipal Corporation Ordinance, 2021 (Tamil Nadu Ordinance 7 of 2021), until the day on which the first meeting of the council of the said Corporation is held after ordinary elections to the said Corporation after the date of commencement of the said Ordinance that is, 20th December 2021 or until the 19th day of June 2022, whichever is earlier;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 10 of the Kumbakonam City Municipal Corporation Ordinance, 2021 (Tamil Nadu Ordinance 7 of 2021), the Governor of Tamil Nadu hereby appoints the Commissioner of Kumbakonam City Municipal Corporation, as the Special Officer of the Corporation.

2. This Notification shall come into force with effect on and from the 1st January 2022.
