2. The Honorarium and allowances, and other terms and conditions of services of the Chairperson and Members shall be as per the Tamil Nadu State Commission for Women (Honorarium, Allowances and Conditions of Service of Chairperson and Members) Rules, 2013.

3. The Chairperson and Members of the said Commission shall hold office for a period of three years.

4. The tenure of other two existing Members of the Tamil Nadu State Commission for Women who were nominated by the Government among the Members of the Legislative Assembly will cease to be the Members of the Commission from the date on which they cease to be the Members of the Tamil Nadu Legislative Assembly.

5. There shall not be any change in the official members of the Commission.
