The Government of Tamil Nadu having been satisfied that the lands specified in the Schedule below are acquired under Chennai Peripheral Ring Road Project for Highways Department purpose to wit, for formation of road for providing connectivity from Ennore Port to Mahabalipuram (from K.M.29+533 to K.M.31+197) at No.99 Athivakkam Village Block-I, Uthukottai Taluk, Tiruvallur District and it having already been decided that the entire amount of compensation to be awarded for the lands to be paid out of the funds controlled and managed by the Highways Department and after having considered the cause shown by the owners or other persons having interest on such lands, as the case may be, do hereby publish the following notice under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002) read with the Tamil Nadu Land Acquisition Laws (Revival of Operation, Amendment and Validation) Act, 2019.
