WHEREAS the Tamil Nadu State Election Commission has fixed 26-03-2022 as the date for convening a meeting to elect the Chairman and Vice Chairman of Aduthurai Town Panchayat of Thanjavur District vide reference first read above;

WHEREAS, a writ petition in W.P.No. 5433/2022 has been filed by Thiru Ma.Ka. Station, 12th Ward Member of Aduthurai Town Panchayat along with 7 other ward members of that town panchayat before the Hobn'ble High Court of Madras and the case has been heard by the Hon'ble High Court on 9-3-20222, 10-3-2022, 11-03-2022 and 15-3-2022. On 11-3-2022, the Honble High Court directed to produce the CCTV footage of the day of election (4-3-2022) on the next date of hearing ie. 15-3-2022;

WHEREAS, the case has been taken for futhher hearing on 15-3-2022, he Retainer of this Commission, in the reference second read above, stated that the Hon'ble High Court of Madras, after viewing the contents of the CCTV footage of election meeting held on 4-3-2022, expressed theat the Returning Offier could have exercised due care in holding the indirect elections and directed the Commission to revisit the decision of the Commission to hold the indirect election on 26-3-2022 for Aduthurai Town Panchayat and to fix the earliest possible date for holding the indirect elections for convening a meeting to elect the Chairman and Vice Chairman of Aduthurai Town Panchayat of Thanjavur District, and

Whereas in view of the above observation of the Hon'ble High Court of Madras in W.P. No. 5433/2022, dated 15-3-2022, the Tamil Nadu State Election Commission has decided to advance the date already fixed for the meeting to elect the Chairman and Vice Chairman of Aduthurai Town Panchayat of Thanjavur District.
