The Government of Tamil Nadu having been satisfied that the lands specified in the Schedule below to be acquired for Highways purpose to wit, for formation of road for providing connectivity from Ennore Port to Mahabalipuram (from Km. 60.881 to 65.967) at Tiruvallur District, Tiruvallur Taluk, No.104 Polivakkam (Block - III) Village and it having already been decided that the entire amount of compensation to be awarded for the lands to be paid out of the funds controlled and managed by the Highways Department.
