Chelladurai, Chairman, Virudhachalam Panchayat Union Council, Cuddalore district had been carried with a support of sixteen members out of the sanctioned strength of nineteen members of the said Panchayat Union Council in the meeting convened by the Revenue Divisional Officer, Virudhachalam, Cuddalore district on the 05th March 2022 after following the procedures specified in the said section 212 and forwarded the same to Government;
