The Government of Tamil Nadu having been satisfied that the lands specified in the schedule below to be acquired for Highways purpose to wit for the formation of Valangaiman by-pass Road at Thillaiyambur Village, Kumbakonam Taluk, in the District of Thanjavur, and it having already been decided that the amount of compensation to be awarded for the lands to be paid out of the funds controlled and managed by the Divisional Engineer (Highways), Construction and Maintenance, Thanjavur.
