The Government of Tamil Nadu having been satisfied that the lands specified in the schedule below to be acquired for Highways purpose to wit for the formation of Kumbakonam By-Pass Road (Phase-III) at Cholanmaligai Village, Kumbakonam Taluk in the District of Thanjavur, and it having already been decided that the entire amount of compensation to be awarded for the lands to be paid out of the funds controlled and managed by the Divisional Engineer (Highways), Construction and Maintenance, Thanjavur. The following notice is issued under sub-section (1) of section 15 of the Tamil Nadu Highways Act, 2001 (TN Act 34 of 2002).
