NOTICE UNDER SUB-SECTION (1) OF SECTION 15 OF THE TAMIL NADU HIGHWAYS ACT, 2001 READ WITH THE TAMIL NADU LAND ACQUISITION LAWS. (REVIVAL OF OPERATION, AMENDMENT AND VALIDATION) ACT, 2019.

The Government of Tamil Nadu having been satisfied that the lands specified in the Schedule below to be acquired for Highways purpose to wit, for formation of road for providing connectivity from Ennore Port to Mahabalipuram (from Km. 60.881 to 65.967) at Tiruvallur District, Tiruvallur Taluk, No.104. Polivakkam (Block-I) Village and it having already been decided that the entire amount of compensation to be awarded for the lands to be paid out of the funds controlled and managed by the Highways Department. The following notice is issued under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34/2002).

Under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002), the Governor of Tamil Nadu hereby acquires the Dry and Wet Patta lands specified in the schedule **06.86.60 Hectare (68,660 Sq.Mtrs.)** to the same, a little more or less needed for the purpose to wit for formation of road for providing road connectivity from Ennore Port to Mahabalipuram (from Km. 60.881 to 65.967) as part of Chennai Peripheral Ring Road Project, by Highways department.
