REMOVAL OF CHAIRMAN OF THE KADAMALAIKUNDU-MYLADUMPARAI PANCHAYAT UNION COUNCIL, THENI DISTRICT UNDER THE TAMIL NADU PANCHAYATS ACT, 1994.

WHEREAS, a written complaint petition signed by ten Ward Members out of the sanctioned strength of fourteen Members of the Kadamalaikundu-Myladumparai Panchayat Union Council, Theni district against Tmt.S.Chandra Santhosam, Chairman of the said Kadamalaikundu-Myladumparai Panchayat Union Council, Theni district has been submitted to the Government as per clause (b) of sub-section (1) of section 207 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994);

AND WHEREAS, a show cause notice under sub-section (1) of the said section 207 was issued against Tmt.S.Chandra Santhosam, Chairman, Kadamalaikundu-Myladumparai Panchayat Union Council, Theni district to submit her explanation within ten days from the date of receipt of the said notice. She has submitted her

AND WHEREAS, a copy of the show cause notice along with the Explanation submitted by Tmt. S.Chandra Santhosam, Chairman, Kadamalaikundu-Myladumparai Panchavat Union Council, Theni district were forwarded to the Revenue Divisional Officer, Periyakulam, Theni district with a proposal for the removal of the said Chairman from office, for ascertaining the views of the said Panchayat Union Council under sub-section (2) of the said section 207;

AND WHEREAS, the Revenue Divisional Officer (i/c), Periyakulam, Theni district convened the Panchayat Union Council meeting on 10.06.2022 by following the procedure prescribed in the said section 207. Then, the Revenue Divisional Officer (i/c), Periyakulam, Theni district has forwarded the minutes of the said meeting to the Government as per sub-section (11) of the said section 207, wherein it is ascertained that, 11 ward members of the said Council were present and out of 11 members 10 members confirmed the complaints already forwarded to the Government and requested to remove Tmt.S.Chandra Santhosam from the office of Chairman, Kadamalaikundu-Myladumparai Panchayat Union Council, Theni district under the said section 207;

(393) [1] AND WHEREAS, the Government, after considering the complaint petition of the ten ward members of the Kadamalaikundu-Myladumparai Panchayat Union Council, Theni district, the explanation submitted by the said Chairman and the views of the said Panchayat Union Council, have decided to remove Tmt.S.Chandra Santhosam, Chairman, Kadamalaikundu-Myladumparai Panchayat Union Council, Theni district from the office of the Chairman of the said Panchayat Union Council;

NOW THEREFORE, in exercise of the powers conferred by sub-section (12) of section 207 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994), the Governor of Tamil Nadu, hereby removes Tmt.S.Chandra Santhosam, Chairman, Kadamalaikundu-Myladumparai Panchayat Union Council, Theni district from the office of the Chairman of the said Panchayat Union Council with immediate effect.
