IMPLEMENTATION OF PRICE SUPPORT SCHEME (PSS) FOR PROCUREMENT OF GREENGRAM IN TAMIL NADU

Crop calendar and Harvesting period
of Greengram in the State of Tamil Nadu.

A remunerative and stable price environment for Greengram growers/farmers is very important for increasing agricultural production and productivity. The market price for agricultural produce many times tends to be unstable and volatile which may result in undue losses to the growers and discourage adoption of the modern technology and required inputs.

The Government's price policy for agricultural commodities seeks to ensure remunerative prices to the growers for their produce with a view to encourage higher investment and production and to safeguard the interest of consumers by making available supplies at reasonable prices with low cost of intermediation. The price policy also seeks to evolve a balanced and integrated price structure in the perspective of the overall needs of the economy.

Towards this end, the Government announce Minimum Support Prices (MSP) for major agricultural commodities each year in both the Crop seasons after taking into account the recommendations of the Commission for Agricultural Costs and Prices (CACP).

In the scheme for the procurement of Greengram in the year of 2022-2023 Kharif season as per the guidelines for PSS (Oil Seeds, Pulses and Cotton) May 2014 issued by the Government of India, (Department of Agriculture and Co-operation), the notification regarding Crop calendar and harvesting period of Greengram in the State of Tamil Nadu is to be required as part of proposal.

Therefore, the Government of Tamil Nadu is willing to implement the Price Support Scheme (PSS) and its operation in Tamil Nadu and accordingly declare the following details:-

NOTIFICATION FOR GREENGRAM IN TAMIL NADU–KHARIF 2022-2023

1. Crop : Greengram
2. Commodity to be notified : Greengram
3. Crop calendar year : April to October
4. Sowing Period : April to August
5. Harvesting period : July to October
6. Commencement of arrival : 2nd week of July 2022
7. Peak arrival period : August 2022 to September 2022
8. Expected Quantity of Procurement : 4000 MT
9. Proposed duration of the scheme : 15.07.2022 to 12.10.2022–Salem, Namakkal, Vellore, Thirupathur, Dharmapuri, Krishnagiri, Thiruvannamalai and Virudhunagar
1.10.2022 to 29.12.2022–Madurai & Namakkal
10. Details of Greengram Production (Kharif) in Tamil Nadu
 - (a) Area : 18,296 ha (In 9 districts during Kharif season as per 2020-21 Final Estimate)
 - (b) Expected production : 16,000 MT
 - (c) Average yield : 875 Kgs/ha
 - (d) Ruling Market Price : Rs.60 to Rs.75 per Kg of Greengram
 - (e) Minimum Support Price : for 2022-2023 Rs.7755/-per quintal
 - (f) Major Kharif growing districts : Salem, Namakkal, Vellore, Thirupathur, Dharmapuri, Krishnagiri, Thiruvannamalai, Virudhunagar and Madurai.
