**DECLARATION OF ELEPHANT RESERVE IN TIRUNELVELI AND KANNIYAKUMARI DISTRICTS**

**WHEREAS**, the Asian Elephant is considered to be a premier flagship species whose presence is a crucial indicator of the health of a forest eco-system,

**AND WHEREAS** the Government of Tamil Nadu is deeply committed to conserve Elephants and their habitats,

**AND WHEREAS** the forest areas of Kalakad Mundanthurai Tiger Reserve and Kanniyakumari Wildlife Sanctuary in Agasthyamalai landscape constitute most important habitats of Asian Elephants in the southernmost part of the Western Ghats,

**AND WHEREAS** the Government of Tamil Nadu has decided to ensure conservation of the rich elephant habitats in the area and to also to enrich the health and connectivity of the elephant migratory paths in Agasthyamalai landscape through proper research and effective management techniques,

**AND WHEREAS** the Government of India, in their letter No. F. No. 7-2/2022-PE, dated 13.07.2022 have conveyed their consent for creation of **Agasthyamalai Elephant Reserve** in the State of Tamil Nadu for the purpose of elephant conservation,

**AND WHEREAS** for the afore stated purposes, the Government of Tamil Nadu have decided to notify **Agasthyamalai Elephant Reserve** with a total area of 1,19,748.26 hectares, constituting following areas listed in the Schedule below.
