In exercise of powers conferred by sub-section (1) of section 28 of the Protection of Children from Sexual Offences Act, 2012 (Central Act 32 of 2012) and in supersession of Home Department Notification No.II(2)/HO/ 927(a-2)/2019 published at pages 2-4 of Part II – Section 2 of the *Tamil Nadu Government Gazette*, dated 20.11.2019, as subsequently amended, the Governor of Tamil Nadu, in consultation with the Chief Justice of the High Court, Madras, hereby designates the following (Special Courts) specified in column (3) of the table below as Principal Special Courts exclusively to try the offences under the Protection of Children from Sexual Offences Act, 2012 (Central Act 32 of 2012) within the local area of the respective districts specified in column (2) thereof and designates the existing Mahila Courts / Fast Track Mahila Courts specified in column (4) of table below as Additional Special Courts and also designates the existing Mahila Courts / Fast Track Mahila Courts specified in column (5) of table below as Special Courts to try the offences under the said Act in addition to the regular work, within the local area of the respective districts specified in column (2) thereof:-
