REMOVAL OF DISTRICT PANCHAYAT CHAIRMAN OF THE THOOTHUKUDI DISTRICT UNDER THE TAMIL NADU PANCHAYATS ACT, 1994.

WHEREAS, a written notice of the intention to make a motion expressing want of confidence in Tmt.R.Sathya, District Panchayat Chairman, Thoothukudi district, signed by thirteen members, out of the sanctioned strength of seventeen members of the said District Panchayat, together with a copy of the motion proposed to be made and a written statement of charges against the said District Panchayat Chairman have been delivered to the District Collector, Thoothukudi district in person by two members as per sub-section (2) of section 212 read with section 213 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994);

AND WHEREAS, the District Collector, Thoothukudi district caused a copy of the statement of charges along with a copy of the notice of motion to be delivered, to the said District Panchayat Chairman, Tmt.R.Sathya and she had not submitted her reply to the charges;

AND WHEREAS, a motion expressing want of confidence in Tmt.R.Sathya, District Panchayat Chairman, Thoothukudi district had been carried with a support of fifteen members out of the sanctioned strength of seventeen members of the said District Panchayat in the meeting convened by the District Collector, Thoothukudi district on the 13th September 2022 after following the procedures specified in the said section 212 read with section 213 and forwarded the same to Government;

NOW THEREFORE, in exercise of the powers conferred by section 213 read with sub-section (13) of section 212 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994), the Governor of Tamil Nadu hereby removes Tmt.R.Sathya, District Panchayat Chairman, Thoothukudi district from the office of the District Panchayat Chairman, Thoothukudi district with immediate effect.
