NOTIFICATION OF KADAVUR SLENDER LORIS SANCTUARY IN KARUR AND DINDIGUL DISTRICTS OF THE WILD LIFE (PROTECTION) ACT, 1972.

[G.O. Ms. No. 175, Environment, Climate Change and Forests (FR.5), 12th October 2022, பரட்டாசி 25, சுபகிருது, திருவள்ளுவர் ஆண்டு–2053.]

WHEREAS, the Government of Tamil Nadu considers that the area specified in the Schedule below is of adequate ecological importance and significant for conservation, protection and propagation of nearly threatened primate species, namely, Slender Loris.

AND WHEREAS, Slender Loris is small nocturnal mammal and arboreal in nature, they spend most of their life on trees. The species acts as a biological predator to pests of agricultural crops and benefits farmers. The species has wide range of ecological role and importance to play in the terrestrial ecosystem;

AND WHERAS, Slender Loris is one among the endangered species in South India and its survival depends on its habitat improvement, conservation research, monitoring of population and habitats and mitigation of threats;

AND WHEREAS, the area measuring 11,806.56 hectares in extent, comprising of Reserve Forests of Dindigul and Karur districts, is an important habitat for Slender Loris in Southern India;

AND WHEREAS, realizing the immediate needs for the conservation of this species, the Government of Tamil Nadu is committed to develop its habitats in Dindigul and Karur districts as Wildlife Sanctuary;

NOW, THEREFORE, in exercise of the powers conferred by clause (b) of sub-section (1) section 26-A of the Wild Life (Protection) Act, 1972, (Central Act 53 of 1972), the Governor of Tamil Nadu, having considered that the area, the boundaries of which are specified in the Schedule below, is of adequate ecological, faunal, floral, natural and zoological significance for the purpose of protecting, propagating and developing wildlife and its environment, hereby declares that the said area shall be a sanctuary, with effect on and from 12th October, 2022.
